- Picture ID
- Social Security card (or Individual Tax Identification Number) for yourself and each dependent you are claiming, including spouse
- If filing jointly, spouse must be present
- W-2s and/or 1099s
- Employer ID numbers or SS number of childcare providers
- Last year's tax returns, if itemizing
- Checking or savings account information, if you want direct deposit of any refund
